

CONFIRMATION ACCEPTANCE OF SCHOLARSHIP

I hereby **confirm that I wish to accept** my Stipendium Hungaricum scholarship, granted by Tempus Public Foundation – based on the decision of its Board of Trustees in 2017 (June/July) of for studies in Hungary starting from the academic year 2017/2018.

By accepting the scholarship, I acknowledge and accept that I am bound by all regulations of the Stipendium Hungaricum programme. I understand that in order to receive a monthly grant, a Scholarship Agreement has to be in place between me; the Scholarship Holder and the allocated higher education institution. The regulations of the programme form the annex of the Scholarship Agreement.

I accept that in order to participate in the scholarship programme, I am required to get enrolled and registered at the allocated higher education institution until **30th September 2017 – or the official deadline of enrolment of the study programme**. I acknowledge that if I am not a registered student until this deadline, I am automatically excluded from the scholarship programme – unless I submit a postponement request that Tempus Public Foundation accepts. I accept that I will only be able to enrol to the host university in the academic year 2017–2018 if I turn 18 years old until 1st of October 2017 – or until the exact enrolment date of my studies funded from the scholarship. I acknowledge that underage Scholarship Holders might postpone their enrolment with maximum two semesters by submitting a postponement request.

Provided that my scholarship status is “conditional”, I accept to submit my missing application documents (proof of language or certificates of qualification, other requested documents) for Tempus Public Foundation. In such cases, I approve to upload all missing documents to the online application surface **no later than 1st of August 2017**.

By accepting the scholarship, I agree that Tempus Public Foundation and the allocated higher education institution may collect, process and use my personal data submitted as part of the application and enrolment process. The data is collected, processed and used for purposes of checking the eligibility for participation in the programme; follow up, reporting and financial monitoring; the preparation of statistics, informational materials, surveys and research. My personal data can be stored and handled for 10 years. Data can be handled by the relevant employees of the Tempus Public Foundation and the higher education institution, participants of the reporting and monitoring processes; authorities responsible for supervision and inspection; and anonymous experts and researchers analysing the implementation and the impact of the programme. All safety measures shall be done in order to ensure data protection with special regard against unauthorized access, modification, forwarding, publication, deletion or destroy, as well as incidental destruction and damage. I confirm that all information I provided as part of the application and enrolment process is, to the best of my knowledge, accurate and true. I am fully aware that false statements will disqualify me from the scholarship programme.

I confirm that I have read, understand and agree to the content of this confirmation and the above procedures for participation in the Stipendium Hungaricum scholarship programme.
