Europass



A proposal for a new Europass Decision was adopted by the Commission as part of the New Skills Agenda for Europe in October 2016.

Adopted by the Council the 12th April 2018. This will include the establishment of a Europass Advisory Group to work with the Commission on the implementation of the Decision. Implementation of Europass will be incremental.

The new Europass platform plans to "documenting and describing skills and qualifications acquired through working and learning experiences, including through mobility and volunteering".

ErasmusPRO

Preliminary analysis of E+ 2018 applications

Almost all Member states have project applications for ErasmusPRO (Except Luxembourg)

Countries with the largest number of applications for ErasmusPRO are: Italy, France, Spain, Netherlands, Germany, Austria. Represent 85% of all demand for ErasmusPRO.
