Type of applicant organisation: Towns/municipalities or their twinning committees or other non-profit organisations representing local authorities.

Number of Partners: A project must involve municipalities from at least 2 eligible countries of which at least one is an EU Member State.

Budget Maximum eligible grant for a project: 25.000 euro

Specifically the Project

The project is aimed to foster the "culture of inclusiveness" towards immigrants inside the social fabric through an exchange of Knowledge and Best practice with other european reality.

Duration of the project and activity

The duration of the project will be of 2 days exluding the day of arrival and the day of leaving. It will take part in a period between the 1° July 2017 and the 30° March 2018. In these days will be performed the following activities:

- Conference "The Europe and Immigrants, EU and National laws". The Conference will
 be on the analysis of the differences between the national laws and European laws
 toward immigration.
- **2.** Meeting "Sharing Experience". The meeting will be on sharing experiences of a successfull integration process and experiences of best practice of reception of immigrants in other nations.
- **3.** Seminar "Culture in Meeting": Seminar about the different culture of the partner involved and the possible way of integration with the culture of the immigrants.
- **4.** Workshop "Language in Meeting": Workshop about the linguistic differences of the partecipant.
- **5.** Social activities and field trips in order to evaluate the culture of the hosting partner.

Long-Term Outcome

The medium and long term outcome that the project attend to achieve are: - A development of the "Culture of inclusiveness" towards immigrants; - A raise understanding and solidarity toward immigrants; - To offer new ideas and consideration about immigrant arrival on which public entities, associations, private entites, citizenship and the immigrants will have to work in order to foster a







process of social-economic integration.

In order to guarantee these results, the municipality involved will create a twinning committees that will continue to share knowledge and practice about the immigration theme also after the end of the project.
